Videotron Ltd. Prices US\$600,000,000 Senior Notes Offering

Montreal, March 31, 2017 - Videotron Ltd. today announced the pricing of its new issuance of US\$600 million aggregate principal amount of 5.125% Senior Notes due 2027. The new senior notes will be sold at par, will carry a coupon of 5.125% and will mature on April 15, 2027. Videotron intends to use the proceeds of this offering to redeem and retire the entire outstanding amount of 6%% Senior Notes due 2021 (the **2021 Notes**) on or around May 1, 2017 pursuant to a notice of redemption transmitted pursuant to the indenture governing the 2021 Notes, to repay drawings under its revolving credit facilities and to pay transaction fees and expenses. Strong demand allowed Videotron to price the issuance at the low end of price talk.

This press release is not an offer to sell or the solicitation of an offer to buy securities in the United States or in any other jurisdiction. The senior notes due 2027 mentioned herein have not been and will not be registered under the United States Securities Act of 1933 or applicable state securities laws, and the senior notes may not be offered or sold in the United States absent registration or an applicable exemption from registration. The senior notes have not been and will not be qualified for sale to the public under applicable Canadian securities laws and, accordingly, any offer and sale of the notes in Canada will be made on a basis which is exempt from the prospectus and dealer registration requirements of such securities laws. This press release does not constitute a notice of redemption with respect to the 2021 Notes. Any redemption of the 2021 Notes.

Videotron (www.videotron.com), a wholly owned subsidiary of Quebecor Media Inc., is an integrated communications company engaged in cable television, interactive multimedia development, Internet access, cable telephone and mobile telephone services. Videotron is a leader in new technologies with its illico interactive television service and its broadband network, which supports high-speed cable Internet access, analog and digital cable television, and other services. As of December 31, 2016, Videotron was serving 1,690,800 cable television customers, including 1,587,000 Digital TV subscribers, while Club illico, the over-the-top video service, had 314,700 members. Videotron is also the Québec leader in high-speed Internet access, with 1,612,800 subscribers to its cable service as of December 31, 2016. As of the same date, Videotron had 893,900 subscriber connections to its mobile telephone service and was providing cable telephone service to 1,253,100 Québec households and organizations. For the twelfth consecutive year, Videotron was ranked as Québec's most respected telecommunications company, based on a Léger survey.
